Mountain conditions are very tough on your roof. We strongly recommend a winter maintenance contract to maintain the life of your roof and keep your warranty in good standing. Please return this completed and signed contract back to our office a.s.a.p. (You may fax it back at the above number; BUT the original must follow by regular mail to the above address).

The Roofing Company will inspect your property for your on a regular basis and will remove the snow and ice for you.

OUR PRICES FOR ROOF ICE & SNOW REMOVAL SERVICES AND WINTER MAINTENANCE ARE AS FOLLOWS:

- \$38.00 PER MAN-HOUR MONDAY - FRIDAY 8:00 AM TO 5:00 PM - 2 man minimum**
- \$48.00 PER MAN-HOUR FOR EMERGENCY AND AFTER HOURS - 2 man minimum**
- \$75.00 PER HOUR FOR BOBCAT GROUND REMOVAL (DRIVEWAY AREA)***

(ADDITIONAL FEES MAY BE CHARGED FOR SPECIAL EQUIPMENT AND MATERIALS SUCH AS MATERIALS SUCH AS PROPANE, TORCHES AND ICE MELT.)

Pay by phone is available via Kim Raffety at (970) 887-0104 Ext. 206. We accept Visa, Mastercard, American Express and checks. Invoices are due upon receipt. Payments due that exceed 30 days will be charged 1.5% interest charges. Collection fees will be added to any unpaid balances.

Snow will be removed for the deck, entryway and walkway after roof removal. Our ground removal is clearing only the areas of the driveway & pedestrian walkways that are precipitated by our workers roof snow and ice removal. If a Bobcat is needed, we will charge you at the Bobcat hourly rate specified above. (Available in Grand County Only). Any additional areas needing maintenance will be added to your contract.
